Please **READ INSTRUCTIONS** carefully **BEFORE** completing application for the SFIC program.

- 1. If all required documentation are not submitted with this application, the application will not be processed.** All questions must be answered (incomplete or incorrect applications will not be processed). Do not write "N/A" (not applicable) on the application. The SFIC office will not contact you looking for missing information or documentation.
- A student is eligible to receive only one scholarship per year from SFIC or CSF. **If your child is currently in grade K through 8 and receives tuition assistance from the Children Scholarship Fund (CSF) program, do not complete this application. Your CSF Renewal application will be mailed separately.** However, if your child is receiving a CSF scholarship and is completing the 8<sup>th</sup> grade, your child is no longer eligible to receive tuition assistance from CSF to attend Catholic high school. Therefore you can apply for an SFIC Scholarship Grant if you are considering a Catholic high school for your child.
- All previous SFIC Scholarship recipients must submit a completed application every year to be considered.
- If you are undecided about what school your child will attend in 2014-2015, please write TBD (To Be Determined) for name of school when submitting your application.
- This application must be postmarked by **December 31, 2013**. A **\$15** non-refundable **MONEY ORDER** payable to **SFIC** is required (one per family). **NO PERSONAL CHECKS will be accepted.**
- Each child's parents/guardians must provide **copies of pages 1 and 2 of their SIGNED 2012 Federal 1040 and 2012 W2 forms. Do not send any New Jersey state forms or worksheets. Your child must be listed as a dependent on the 2012 Federal 1040.** Married couples filing separately must attach both 2012 Federal 1040 and 2012 W2 forms.
- Any other person(s) claiming your child as a dependent must include **copies of all their signed 2012 Federal 1040 and 2012 W2 forms.**
- If applicable, also include with application your **2012 YEAR-END** Social Security Income, Food Stamps, Housing, Unemployment Benefits, Child Support Assistance, Social Services statements (TANF) etc.
- If your child is not claimed as a dependent by anyone, the child's name must appear on the 2012 Public Assistance documentation and included with the application.
- If you have unusual financial circumstances, which you would like to explain to us, please attach a separate notarized letter and any relevant documentation that will explain your current financial situation.
- Do not call our office regarding your application status. No information will be given over the phone. All approval/denial letters will be mailed after April 15, 2014.
- Make sure to keep copies of all the forms you submitted to our office for your records. You need to notify our office in writing of any change in address, phone number or school, etc.
